



Accused Haider Rehman in person present.</p> <p>Today, the case was fixed for wakalatnama; however, the accused submitted application for disposal of his case on the basis of plead guilty. Statement of accused recorded and notice u/s 243 CrPC given. The accused put himself at the mercy of the Court.</p> <p>The case was registered against the accused Haider Rehman S/O Din Bat Khan, aged about 33/34 years, Qaum Sheikhan, Tappa Samozai, District Orakzai vide case FIR No. 52, Dated: 24.06.2025, u/s 9(1)3(c) CNSA registered at Police Station Mishti Mela, on the basis of recovery of 1000 grams chars from his possession.</p> <p>The case in hand is based upon the recovery of 1000 grams chars which falls under Section 9(1)3(c) CNSA. In view of his clean breast plead guilty, the accused is convicted u/s 9(1)3(c) CNSA to undergo rigorous imprisonment for a period of fourteen (14) years and pay a fine of Rs. 500,000/-. Contin. Order No. 10		<p>According to the local police, there is no other such like case registered against the convict. As such, he is first offender. Besides the convict is of young age; therefore, he must have a chance of reformation and repentance.</p> <p>In view of the above facts, the sentence awarded to the accused is suspended under Section 4-D of the Khyber Pakhtunkhwa Probation and Parole Act, 2021 and the convict is placed under the supervision of the Probation Officer, Orakzai, for a period of one year subject to furnishing surety bonds to the tune of Rs. 100,000/- with two sureties each in the like amount to the satisfaction of the Probation Officer, Orakzai. The sentence of fine shall stands merged with the period of probation. Copy of the Order be sent to the Probation Officer, Orakzai for doing the needful in accordance with probation law/rules.</p> <p>The terms and conditions of probation Order, its effects, bond and the consequences of breaching the conditions during the probation period were explained to the convict in Pashto language as required under Section 6 (4) of the Khyber Pakhtunkhwa Probation and Parole Act, 2021.</p> <p>Case property be destroyed after the period of appeal/revision.
