

Sr. PP, Abul Qasim for the State present.</p> <p>The petitioner seeks return of a CG-125 motorcycle bearing Registration No. FB-1717/Kohat, Chassis No. EA700249 and Engine No. R018090 taken into possession by the local police in case FIR No. 104, Dated 25.12.2025, u/s 9 (1) 3 (e) CNSA and 15AA of Police Station Mishti Mela. As per contents of FIR, the complainant, SHO Shal Muhammad along with other police contingents, during surveillance duty, received information regarding smuggling of chars by Wali Rehman and Hafiz Ullah via motorcycle. Upon this information, he laid a barricade on main road leading from Mishti Mela to Ghiljo on 25.12.2025 when a motorcycle boarded by two persons arrived there at about 1100 hours. The motorcycle was stopped and the persons riding it were disembarked. The driver disclosed his name as Wali Rehman. From the bag tied with his waist, the complainant recovered 6500 grams of chars. He also recovered a 30-bore pistol without number with 05 live rounds from his trouser-fold. The other person disclosed his name as Hafiz Ullah. The complainant also recovered 6500 grams of chars from a white bag tied with his waist.</p>



		<p>I heard counsels for the parties and perused the record.</p> <p>After hearing both the parties and perusal of the record, it was found that the recovery has been made from the bags in possession of the accused and there is no secret cavity in the motorcycle in question. Moreover, the petitioner has produced documents regarding ownership of the motorcycle. There is no rival claimant of the motorcycle in question.</p> <p>In view of above, the petition in hand is accepted and the motorcycle in question be returned to the petitioner subject to furnishing two surety bonds in the sum of Rs. 200,000/- to the satisfaction of this Court. The petitioner is directed not to dispose of the motorcycle till final conclusion of the trial and produced the same as and whenever required to this Court or police.
