





Order No.05	20.01.2026	<p>Accused/petitioner, Fiaz Khan on ad-interim pre-arrest bail with his counsel present. Sr. PP, Abul Qasim for the State present. Arguments heard and record perused.</p> <p>The above-named accused/petitioner seeks pre-arrest in case FIR No. 27, Dated 29.07.2021, u/s 9 (d) CNSA, 4 PO and 15AA registered at Police Station Ghiljo. As per contents of the FIR, the complainant, SHO Saleem Khan along with other police contingents laid a barricade at Krappa Check-Post on 29.07.2021 when a Land Cruiser Jeep arrived there from Ghiljo at 1500 hours. The vehicle was stopped. The person sitting on the front seat of the vehicle was disembarked and a bottle of local wine was recovered from his possession. He disclosed his name as Muhammad Ishtiaq. The complainant deboarded the driver of the vehicle and recovered a 9MM pistol bearing No. TFM20671 with a fixed charger containing 03 live rounds from his trouser-fold. He revealed his name as Dat Ali Jan. Likewise, the person occupying the rear seat of the vehicle was also deboarded and the complainant recovered a white plastic bag placed in between his legs wherein 03 packets of chars, each weighing 1100 grams, making a total of 3300 grams were found. The person disclosed his name as Asif.</p>
