



Accused Sajon present.</p> <p>Today, the case was fixed for submission of Wakalatnama; however, the accused submitted application for disposal of his case on the basis of plead guilty. His statement recorded and notice u/s 243 CrPC is given. He put himself at the mercy of the Court. Report of the SHO concerned regarding previous history of the accused also submitted through Naib Court.</p> <p>The case was registered against the accused Sajon s/o Brikh Muhammad, aged about 35/36 years, r/o Bara, District Khyber vide FIR No. 61, Dated 06.10.2025 at Police Station Kurez Boya u/s 9 (1) 3 (c) CNSA.</p> <p>The case in hand is based upon the recovery of 1200 grams of chars which falls under Section 9 (1) 3 (c) CNSA. In view of his clean breast plead guilty, the accused is convicted u/s 9 (1) 3 (c) CNSA to undergo rigorous imprisonment for a period of fourteen (14) years and pay a fine of Rs. 400,000/-. In default of payment of fine, the accused shall suffer further simple imprisonment for six (06) months.</p> <p>According to the report of local police, there is no other such like case registered against the convict. As such, he is first offender; therefore, he must have a chance of repentance.</p> <p>In view of the above facts, the sentence awarded to the accused is suspended under Section 4-D of the Khyber Pakhtunkhwa Probation and Parole Act, 2021 and the convict</p>
