

Brief facts in the backdrop are that plaintiff has filed the instant
suit for declaration cum-permanent injunction to the effect that, as per
birth certificate issued by GPS Pat Tangi, District Orakzai true and
correct date of birth of plaintiff No.1 is 03.06.2016, plaintiff No.2 is
05.12.2017 and plaintiff No.3 is 09.12.2018, however, defendants have
incorrectly entered the dates of birth are 19.10.2012, 19.10.2014 and
19.10.2015 which are wrong, illegal and ineffective upon the rights of
plaintiff and liable to be rectified. That defendants were asked time and
again to rectify date of birth of plaintiff but in vain hence, the present
suit.

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter was submitted. Written statement filed.

Plaintiff has placed reliance on birth certificate. Per birth certificate issued by GPS Pat Tangi, District Orakzai, date of birth of plaintiff No.1 is 03.06.2016, plaintiff No.2 is 05.12.2017 and plaintiff No.3 is 09.12.2018. Representative of defendants stated that date of birth of plaintiff may be modified as per birth certificate per NADRA SOPs. Birth certificate of plaintiffs is placed on file. Plaintiff shall produce the same to the office of defendants for the modification in dates of birth of plaintiff No.1 is 03.06.2016, plaintiff No.2 is 05.12.2017 and plaintiff No.3 is 09.12.2018. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff No.1 is 03.06.2016, plaintiff No.2 is 05.12.2017 and plaintiff No.3 is 09.12.2018 accordingly. Suit of plaintiffs is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any.
