SUMMARY JUDGEMENT

03.12.2025

Plaintiff through counsel present. Representative of defendants present. Written statement submitted. Representative of defendants stated that there is unnatural age gap between plaintiff and his children. Arguments heard and record gone through.

Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that, her true and correct date of birth of plaintiff is **01.01.1993**, however, defendants have incorrectly entered the same as **01.01.1999** which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That due to this wrong entry, there is unnatural age of about 10 years between plaintiff and his son namely Wahid Khan whose date of birth is 17.04.2009. Similarly, there is unnatural age of about of 11 year and 13 years between plaintiff and his

daughters namely Shumalia Orakzai and Sheela Bibi whose dates of birth are 06.06.2010 and 01.01.2012. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

Representative of defendants stated that there shall be at least 16/17 years' age difference between father and his children. Per record, date of birth of plaintiff is recorded as 01.01.1999. Date of birth of plaintiff's children are recorded as 17.04.2009, 06.06.2010 and 01.01.2012 resulting into unnatural age gap of about 10, 11 and 13 years. Plaintiff is not a government servant. The modification sought by plaintiff will not affect rights of others. Representative of defendants stated that date of birth of plaintiff may be modified as per NADRA SOPs. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as **01.01.1993**. Suit of plaintiff is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiff, if any.
