
Ex-parte Order

Plaintiff through counsel present. Defendant

No.2 to 04 through representative present. Defendant No.1
 absent despite service, therefore, placed and proceed ex-
 parte. Ex-parte arguments heard and record perused.

Brief facts in the backdrop are that plaintiff has filed
 the instant suit against the defendants for declaration and
 permanent injunction to the effect that as per Form-B issued
 by NADRA and primary school leaving certificate correct
 date of birth of plaintiff is 02.02.2010, however, defendant



No.1 has incorrectly entered date of birth of plaintiff as **02.02.2009** which is wrong, illegal and liable to be rectified. That defendant No.1 was asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned. Defendant No.2 to 04 through representative appeared before the court and filed authority letter and written statement, while defendant No.1 has proceeded ex-parte.

Plaintiff has placed reliance on Form-B issued by NADRA and primary school leaving certificate, wherein date of birth of plaintiff is mentioned as 02.02.2010. Copy of Form-B and primary school leaving certificate is placed on file. Date of birth of plaintiff is recorded as 02.02.2010 in Form-B issued by NADRA and primary school leaving certificate, therefore, defendant No. 01 (Board of intermediate & secondary education Kohat) is directed to rectify date of birth of plaintiff as **02.02.2010** accordingly. There is nothing in rebuttal due to ex-parte while plaintiff produced documentary evidence in support of his claim.

As there is nothing in rebuttal due to ex-parte of defendant No.1 and plaintiff produced reliable evidence, therefore, suit of plaintiff is hereby ex-parte decreed as
