


Order No. 05	29.01.2026	<p>Sr. PP for the State present. Accused Sahar Ali along with counsel present. Mr. Abid Ali Advocate submitted wakalatnama in favour of accused as pauper counsel which is forwarded for approval by the DLEC.</p> <p>The accused submitted an application for disposal of his case on the basis of plead guilty. Statement of the accused recorded wherein he stated that he is behind the bar in the instant case since the date of registration of FIR. He is not able to produce sureties in spite of acceptance of his bail application as his family members are not willing to produce sureties for him. He shall remain peaceful with his father and family members. Notice u/s 243 CrPC given. The accused put himself at the mercy of the court and requested for disposal of the case on the basis of plead guilty.</p> <p>The case was registered against the accused Sahar Ali S/O Jameen Ali, aged about 22/23 years, Qaum Bar Muhamamd Khel, Kurez, District Orakzai vide case FIR No. 65, Dated: 17.10.2025, u/s 9(1)3(c) & 11(1)1 KP</p>

Order No. 05 Continued...	29.01.2026	<p>CNSA registered at Police Station Kurez Boya, on the basis of recovery of 1000 grams chars & 19 grams ICE from his possession.</p> <p>The case in hand is based upon the recovery of 2400grams chars and 19 grams ICE which falls under Section 9(1)3(c) & 11(1)1 KP CNSA. The record is silent about involvement of the accused in such like other cases. In view of his clean breast plead guilty of the accused and his inability to produce sureties for his release, while taking lenient view, the accused is convicted u/s 9(1)3(c) & 11(1)1 KP CNSA to undergo rigorous imprisonment for a period of 03 months each and pay a fine of Rs. 400,000/- & Rs. 50,000/- respectively. In default of payment of fine, the accused shall suffer further simple imprisonment for ten (10) days each. Both the punishments shall run concurrently with the benefit of Section 382-B Cr. PC.</p> <p>Case property be destroyed after the period of appeal/revision.
