



Both the parties were heard today.</p> <p>Brief facts of the instant execution are that defendant/JD categorically had stated in his statement that he has no objection to the re-marriage of the plaintiff/DH and he will return all the belongings/dowry articles of the DH to her without any delay. That despite the said clear undertaking and statement made on oath before this Court, the JD is now reluctant and has refused to comply and has failed to honor his own statement as well as the Court order dated: 10.11.2025. Thus, the non-compliance on part of the JD amounts to willful disobedience, causing hardship and inconvenience to the DH. Furthermore, the DH is entitled to the execution and enforcement of the order dated: 10.11.2025 alongwith the recovery of her belongings as admitted by the JD.</p> <p>Defendants was summoned who appeared before the court and marked his attendance.</p> <p>Vide order dated: 10.11.2025, both the parties appeared and submitted that the dispute between them has been amicably settled. As per statement JD Muhammad Younas stated that he is willing to return all the belongings to DH Mst: Shazida Bibi.</p> <p>Today, JD Muhammad Younas again stated that he has no objection for returning all the belongings to Mst: Shazida Bibi. To this effect, counsel for DH requested before the court to direct bailiff of the court to visit the residence of the Judgment Debtor (JD) for recovery of the belonging/dowry articles and hand over the same to DH.</p> <p>Report of bailiff received, which is placed on file. As per the bailiff's report, he visited the house of the JD in compliance with the Court's orders and recovered the dowry articles as detailed therein. The bailiff further stated that the recovered belonging/dowry articles were duly handed over to Mst. Shazida Bibi, the Decree Holder in the presence of the relative namely Yousaf Khan. The report bears the thumb impression of Mst. Shazida Bibi and Yousaf Khan as acknowledgment of receipt. Furthermore, the signature/thumb impression of the brother of the DH has also been obtained as a witness to the handing-over process. No objection has been raised from any quarter regarding the said proceedings.</p> <p>In view of the verified report of the bailiff and proper acknowledgment of receipt of the dowry articles by the DH,</p>
