




Order No. 09	22.12.2025	<p>Sr.PP, Abul Qasim for the State present. Accused present.</p> <p>Today, the case was fixed for evidence; however, the accused submitted application for disposal of his case on the basis of plead guilty. His statement recorded and notice u/s 243 CrPC is given and put himself at the mercy of the court.</p> <p>The case was registered against the accused Hadeeq S/O Noor Zali, aged about 16/17 years, Caste Bezote, District Orakzai, vide FIR No. 35, Dated 22.04.2025 at Police Station Kalaya u/s 9(d) CNSA.</p> <p>According to averments of the FIR, the SHO Police Station Kalaya along with other police contingents were on surveillance duty in the area on 22.04.2025 when a pedestrian having a white colour plastic bag in his right hand was stopped for checking. His personal search was conducted, but nothing incriminating was recovered. The search of the plastic bag led to the recovery of 2000 grams Chars Gardah which were weighed through digital scale. The sample of 01 gram was separated from the total quantity and sealed into parcel No. 1. The remaining 1990 grams of chars were sealed in parcel No. 2. Videography of the occurrence was carried out and sealed into parcel No. 3. The parcels were sealed with the monogram of "SH". The accused disclosed his name as Hadeeq S/O Noor Zali Jan, R/O Qaum Bezote. The Murasila and other documents were sent to police station; hence, the FIR was registered.</p>

<p><b>Contin.</b> <b>Order No. 09</b></p>	 <b>Haq Nawaz</b> <b>District &amp; Sessions Judge</b> <b>Orakzai at Baber Mela</b>	<p>The case in hand is based upon the recovery of 2000 grams Chars Gardah which falls under Section 9(d) of the Khyber Pakhtunkhwa CNSA. In view of his clean breast plead guilty, the accused is convicted u/s 9(d) of the Khyber Pakhtunkhwa CNSA to undergo rigorous imprisonment for a period of fourteen (14) years and pay a fine of Rs. 500,000/-. In default of payment of fine, the accused shall suffer further simple imprisonment for six (06) months.</p> <p>According to the report of local police, there is no other such like case registered against the convict. As such, he is first offender. Besides the convict is of young age/juvenile; therefore, he must have a chance of repentance.</p> <p>In view of the above facts, the sentence awarded to the accused is suspended under Section 4-D of the Khyber Pakhtunkhwa Probation and Parole Act, 2021 and the convict is placed under the supervision of the Probation Officer, Orakzai, for a period of two years subject to furnishing surety bonds to the tune of Rs. 100,000/- with two sureties each in the like amount to the satisfaction of the Probation Officer, Orakzai. The sentence of fine shall stands merged with the period of probation. Copy of the Order be sent to the Probation Officer, Orakzai for doing the needful in accordance with probation law/rules.</p> <p>The terms and conditions of probation Order, its effects, bond and the consequences of breaching the conditions during the probation period were explained to the</p>
