

Mr. Taza Khan Advocate submitted an application for discharged of the accused, which is placed on file.</p> <p>Record shows that accused are charged in case F.I.R No. 06 Dated: 24.04.2025 under section 188Pakistan Panel Code, 1860, police station Daboori, District Orakzai.</p> <p>Allegations against the accused are that they boycotted the polio vaccination campaign in violation of the order of the competent authority.</p> <p>Perusal of the record shows that for constituting an offence under Section 188 PPC, it is mandatory that a lawful order must be duly promulgated by a competent authority and its communication/publication must be proved so that the concerned persons had knowledge of such order.</p> <p>In the present case, the prosecution has failed to place on record any material showing that the alleged order regarding the polio campaign was properly promulgated and given wide publicity through recognized modes such as public announcement, notification, or affixation at conspicuous public places. Boycott of a polio campaign, by itself, without proof of a duly promulgated and properly communicated order, does not fulfill the essential</p>


