JUDGEMENT

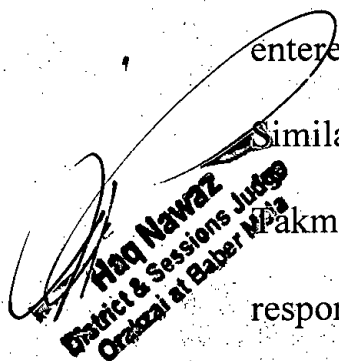

This civil appeal was preferred by the appellant against the judgment and decree dated 27.04.2026 passed by the Court of learned Senior Civil Judge, Orakzai, whereby civil suit No. 13/1 of 2026 was dismissed.

2. According to averments of the plaint, the correct name of father of the plaintiff is Mr. Lala Jan which was wrongly entered in the record of respondents as Muhammad Jan.

Similarly, the correct name of her mother is Mst. Khiyal Akmy which was wrongly entered in the record of respondents as Mst. Socha Gula. She repeatedly asked the respondents to correct their record, but they refused; therefore, the suit was filed.

3. The respondents in their written statement have raised legal and factual objections and submitted that the record of respondents was once changed on the application of the

plaintiff/appellant. Pleadings of the parties were reduced to the following issues;

I. Whether suit is valid in its legal frame and the court is competent to hear it?

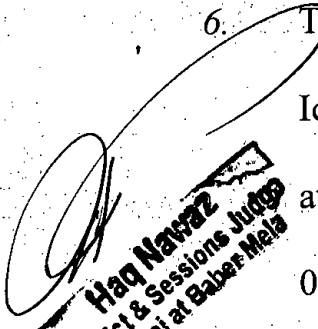
II. Whether correct names of the parents of the plaintiff are Mr. Lala Jan and Mst. Khiyal Takmy while the defendants have wrongly entered their names as Mr. Muhammad Jan and Mst. Socha Gula respectively?

III. Relief.

4. After recording pro and contra evidence and hearing both the parties, the learned trial court dismissed the suit through his impugned judgment and decree, hence this appeal was filed.

5. I have heard learned counsel for the appellant and representative of the respondents and perused the record.

6. The learned trial court has recorded the statements of Javid Iqbal and Muhammad Zahid as CW-01 & CW-02. The attorney for the appellant appeared before the court as PW-01. All the three are sons of Muhammad Jan and they deposed that father name of the appellant is Lala Jan and the name of her mother is Khiyal Takmy. CW-02 further submitted that father of the appellant Lala Jan was his real brother. The appellant in her statement before the court as

CW-03 reiterated that the names of her parents are Lala Jan and Mst. Khiyal Takmy. Two other witnesses were also produced before the court as PW-02 & PW-03. Both of them stated that the father names of the appellant was Lala Jan and the name of her mother was Khiyal Takmy. PW-02 stated in her cross examination that Muhammad Jan is the grandfather of the appellant.

7. On the other hand, representative of the respondents recorded his sole statement as DW-01. He submitted that parents' names of the appellant are rightly entered in their record as Muhammad Jan and Socha Gula and the said entry was made on the application of the appellant.

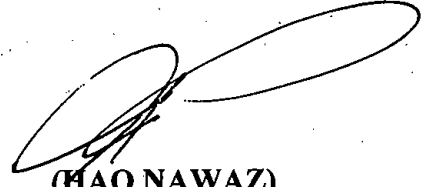
8. The perusal of application for correction of name of the parents of the appellant Ex. DW-1/3 shows that the names of her parents were earlier mentioned as Lala Jan and Khiyal Takmy which were subsequently substituted in the record of respondents as Muhammad Jan and Socha Gula.

9. In view of the above facts and circumstances, the appellant was successful to prove through sufficient evidence that the names of her parents were Lala Jan and Mst. Khiyal Takmy which were incorrectly entered in the record of respondents as Muhammad Jan and Socha Gula. The appeal is, therefore, accepted. The impugned judgment and decree are set aside and suit of the appellant is decreed as prayed for.
