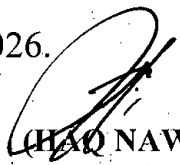
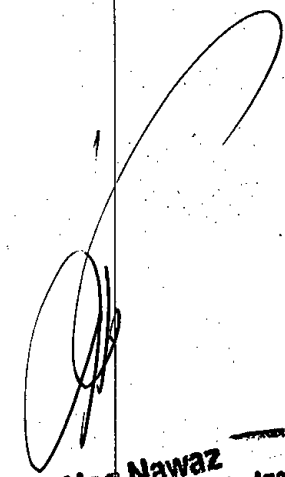


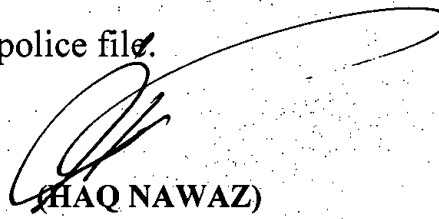

As per contents of the FIR, the local police, while responding to information regarding the incident, rushed to Type-D Hospital Dabori and found the dead body of Abdullah. The uncle of deceased namely Alab Jan made a report to the local police at 1130 hours that he called Sajik with

Order No. 08 Continue	23.07.2026	whom his nephew Abdullah was working as a labor that his nephew has not returned home; upon which he informed that he had left long ago. The complainant and his relatives during the search of his nephew came to know that he was done to death by some unknown accused. Later on, the complainant recorded his statement u/s 164 CrPC on 04.05.2026 and charged the accused/petitioner along with co-accused Bakhtiar Jan for the murder of his nephew. The brother of complainant Marwat Khan along with widow and mother of the deceased appeared before the court and submitted their affidavits as Ex. PA & Ex. PB. they submitted in the affidavit that accused/petitioner was charged on the basis of suspicion regarding his involvement in the commission of offence, however, they have now satisfied themselves about the innocence of the accused/petitioner on the basis of oath taken by him. Therefore, they submitted their no objection on the acceptance of present application. Hence, in view of the above, the ad-interim pre-arrest bail allowed to the accused/petitioner vide order dated 03.06.2026 is confirmed on the strength of existing bail bonds.
