Today the case in hand was fixed for evidence of prosecution, however at the very out set accused facing trial stated at the bar that he want to confess his guilt in the instant case and in this respect he also submitted an application for plead guilty, which is placed on file. Brief facts of the case are that as per version of the complainant in the FIR, that on 04.09.2023 at about 1700 hours, SHO/complainant alongwith police officials were present on barricade. In the meanwhile, one person coming from Daboori side in suspicious condition was stopped for the purpose of checking. Upon his body search, the complainant/SHO recovered and took into possession one envelope in white color from the side pocket containing ice. On weighing through digital scale it came out 47-grams ice. One gram was separate for FSL examination, which was packed and sealed into parcel no. 01 while remaining stuff of ice i.e. 46-grams was duly packed and sealed into parcel no. 02. Accused disclosed his name as Wahid Khan son of Muhammad Ayub Khan.

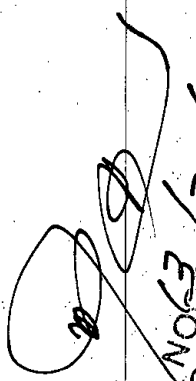

		Accused was arrested on the spot and issued his card of arrest. Murasila was drafted on the spot. Upon the strength of Murasila the instant FIR was lodged against the accused facing trial. Complete challan against the accused was put in court on 10.10.2023 and after 241-A Cr.P.C proceedings, the accused facing trial was formally charge sheeted on 18.10.2023. Initially accused pleaded not guilty and claimed trial. However, today he filed an application for pleading his guilt and requested for lenient view. After pleading his guilt, show cause notice under section 243 Cr.P.C. was given to the accused as to why he should not be convicted. Resultantly, he prayed for lenient view while placing himself at the mercy of this court. It is also pertinent to mention here that there is nothing such available on the record which could suggest that accused facing trial was previously involved in such like cases. There is also no criminal history of the accused available on the file. Keeping in mind the wholehearted confession of guilt by the accused Waheed Khan and being a first offender, a

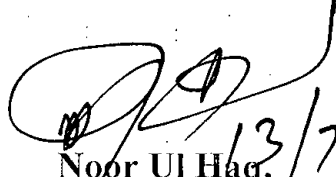

	 NOOR UL HAQ Civil Judge / JM-II Orakzai at Kalaya	lenient view is taken and accused facing trial is convicted and sentenced for offence under sections 11-A CNSA with simple imprisonment of 06 months with fine of Rs. 10,000/-. In default of non-payment of fine the accused shall undergo simple imprisonment for a period of 01-month. Furthermore, there is nothing on record which could show previous involvement of accused in such like cases, being first offender, thus, the sentence and conviction ibid is suspended and converted into probation and he is placed on probation for the period of 06 months. He shall remain under the supervision of the Probation Officer (male) for the above-mentioned period subject to furnishing bail bonds in the sum of Rs. 50,000/- with two local and reliable sureties, to the satisfaction of probation officer (male) Orakzai with the following conditions. - That he shall not repeat the offence. - That he shall keep and maintain peace and order in the society. - That he must exhibit good behavior during the prescribed period of probation. - That he shall appear before the probation officer once in a month, which date is left to the discretion of the probation officer to be fixed.
