At the very out set accused facing trial stated at the bar that he want to confess his guilt in the instant case and in this respect he also submitted an application for plead guilty, which is placed on file. Brief facts of the case are that as per version of the complainant in the FIR, that on 17.02.2026 at about 1900 hours, SHO/complainant alongwith police officials were present on barricade laid down at metal road near Karghan check-post. In the meanwhile, one person through motorcycle coming from Anjani side was stopped and deboarded the driver from the motorcycle, for the purpose of checking. Accused facing trial disclosed his name as Ismail son of Sharbat Khan, resident of Qom Feroz Khel, Lerri, District Orakzai. Upon his body search, no contraband or prohibited article was recovered from his possession, while, searching the motorcycle, a white plastic bag kept in the side cover was recovered. On examination, the recovered substance was ice. On weighing through digital scale it came out 40-

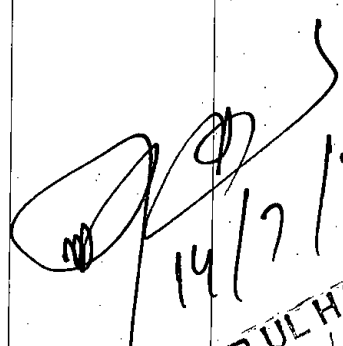

		grams ice. One gram was separate for FSL examination, which was packed and sealed into parcel no. 01 while remaining stuff of ice i.e. 39-grams was duly packed and sealed into parcel no. 02. The videography was made by constable Muhammad Zahid belt no. 2107 through his mobile and saved in the USB, which was duly packed and sealed into parcel no. 03. SHO/complainant prepared recovery memo on the spot in the presence of marginal witnesses. Accused was arrested on the spot and issued his card of arrest. Murasila was drafted on the spot. On the strength of Murasila the instant FIR was lodged against the accused facing trial. Complete challan against the accused was put in court on today and after 241-A Cr.P.C proceedings, the accused facing trail filed an application for pleading his guilt and requested for lenient view. After pleading his guilt, show cause notice under section 243 Cr.P.C. was given to the accused as to why he should not be convicted. Resultantly, he prayed for lenient view while placing himself at the mercy of this court.

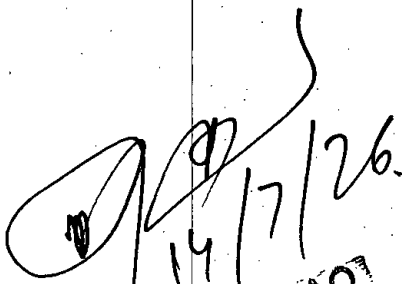

		It is also pertinent to mention here that there is nothing such available on the record which could suggest that accused facing trial was previously involved in such like cases. There is also no criminal history of the accused available on the file. Keeping in mind the wholehearted confession of guilt by the accused Irteza and being a first offender, a lenient view is taken and accused facing trial is convicted and sentenced for offence under sections 11-(i) 2 PKCNSA with simple imprisonment of 06 months with fine of Rs. 10,000/-. In default of non-payment of fine the accused shall undergo simple imprisonment for a period of 01-month. Furthermore, there is nothing on record which could show previous involvement of accused in such like cases, being first offender, thus, the sentence and conviction ibid is suspended and converted into probation and he is placed on probation for the period of 06 months. He shall remain under the supervision of the Probation Officer (male) for the above-mentioned period subject to furnishing bail bonds in the sum of Rs. 50,000/- with two

		local and reliable sureties, to the satisfaction of probation officer (male) Orakzai with the following conditions. - That he shall not repeat the offence. - That he shall keep and maintain peace and order in the society. - That he must exhibit good behavior during the prescribed period of probation. - That he shall appear before the probation officer once in a month, which date is left to the discretion of the probation officer to be fixed. - That he shall not leave the country without permission of probation officer. - That Probation Officer is authorized to involve the probationer in any suitable community service, as provided under Probation and Parole Act. - That if he violates the above conditions, the bonds will be recalled and he will be proceeded in accordance with the provision of the Ordinance <i>ibid</i>. - That in case of default by the convict, the direction regarding probation shall stand recalled and convict shall undergo imprisonment accordingly. - The Probation Officer (male) is directed to submit his report to this court about their character and conditions as aforesaid once in a quarter. Copy of this order be sent to the probation officer for compliance as per law.

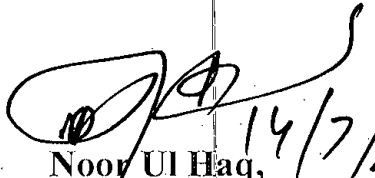
