

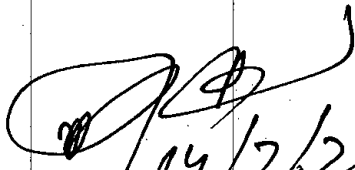

Accused Ismail on bail present.</p> <p>At the very out set accused facing trial stated at the bar that he want to confess his guilt in the instant case and in this respect he also submitted an application for plead guilty, which is placed on file.</p> <p>Brief facts of the case are that as per version of the complainant in the FIR, that on 16.05.2025 at about 1930 hours, SHO/complainant alongwith police officials were present on barricade laid down at metal road near Mirbak-post. In the meanwhile, one person through motorcycle coming from Feroz Khel was stopped and debarked the driver from the motorcycle, for the purpose of checking. Upon his body search, the SHO/complainant recovered and took into possession one plastic envelope in white color from the front pocket, containing ice. On weighing through digital scale it came out 100-grams ice. One gram was separate for FSL examination, which was packed and sealed into parcel no. 01 while remaining stuff of ice i.e. 99-grams was duly packed and sealed into parcel no. 02. Accused disclosed his name as Ismail Khan son of Sharbat Khan. Murasila was drafted on the spot. On the strength of Murasila the instant FIR was lodged against the accused facing trial.</p> <p>Complete challan against the accused was put in court on 14.02.2026 and after 241-A Cr.P.C proceedings, the accused facing trial filed an application for pleading his guilt and requested for lenient view. After pleading his guilt, show cause notice under section 243 Cr.P.C. was given to the accused as to why he should not be convicted. Resultantly, he prayed for lenient view while placing himself at the mercy of this court.</p> |

There is also no criminal history of the accused available on the file.</p> <p>Keeping in mind the wholehearted confession of guilt by the accused Irteza and being a first offender, a lenient view is taken and accused facing trial is convicted and sentenced for offence under sections 11-B PKCNSA with simple imprisonment of 06 months with fine of Rs. 10,000/-. In default of non-payment of fine the accused shall undergo simple imprisonment for a period of 01-month. Furthermore, there is nothing on record which could show previous involvement of accused in such like cases, being first offender, thus, the sentence and conviction ibid is suspended and converted into probation and he is placed on probation for the period of 08 months. He shall remain under the supervision of the Probation Officer (male) for the above-mentioned period subject to furnishing bail bonds in the sum of Rs. 50,000/- with two</p> |

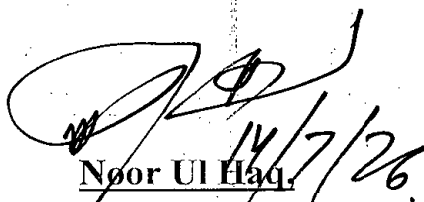
