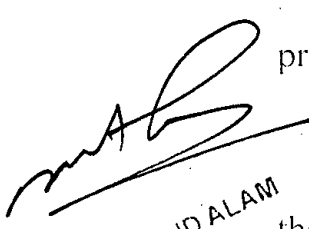
SUMMARY JUDGEMENT

30.04.2025

Plaintiff through counsel present. Representative of defendant
present. Authority letter & written statement already submitted.

Learned counsel for plaintiff requested for summary disposal of
the suit on the basis of available record. Representative of defendants
conceded the same. Arguments heard and record gone through.

Brief facts in the backdrop are that plaintiff has filed the instant
suit for declaration cum-permanent injunction to the effect that, as per
Admission & Withdrawal Register her true and correct date of birth is
05.03.2011, however, defendant have incorrectly entered the same as
11.05.2017 which is wrong, illegal and ineffective upon the rights of
plaintiff and liable to be rectified. That defendants were asked time and
again to rectify date of birth of plaintiff but in vain hence, the present
suit.

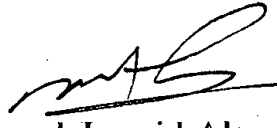

With due process of law and procedure, the defendants were summoned, he appeared through representative. Authority letter and written statement was filed.

Plaintiff has placed reliance on Admission & Withdrawal Register. Per Admission & Withdrawal Register date of birth of plaintiff is recorded as 05.03.2011. Representative of defendants stated that date of birth of plaintiff may be modified as per Admission & Withdrawal Register per NADRA SOPs. Admission & Withdrawal Register verified from Head Teacher of GPS Garhi Mani Khel, Lower Orakzai. Attested record placed on file. As date of birth of plaintiff is recorded as 05.03.2011 in Admission & Withdrawal Register and representative of defendants stated at the bar that NADRA will rectify date of birth of plaintiff on the bases of Admission & Withdrawal Register, therefore, there is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as **05.03.2011** accordingly. Suit of plaintiff is hereby decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. Defendants may verify Admission & Withdrawal Register of plaintiff from authorities concerned, if deemed necessary.
