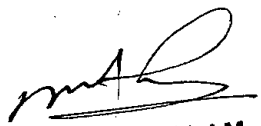

SUMMARY JUDGEMENT

06.05.2025

Plaintiff absent. Representative of defendants present. Written statement submitted. Representative of defendants stated that per record, there is unnatural age gap of 08 and 06 years between plaintiffs with their children, therefore, if suit of plaintiffs is disposed of through summary judgement, he has got no objection. Arguments on behalf of representative of defendants heard and record gone through.

Brief facts in the backdrop are that plaintiffs have filed the instant suit for declaration cum-permanent injunction to the effect that, true and correct date of birth of plaintiff No.1 is 1970 and plaintiff No.2 is 1970 however, defendants have incorrectly entered the same as 1980 and 1982 which entries are wrong, illegal and ineffective upon the rights of plaintiffs and liable to be rectified. That due to this wrong entry, there is unnatural age of about 08 and 06 years between plaintiffs with their children's whose dates of birth are 01.01.1988 & 1988. That defendants were asked time and again to rectify date of birth of plaintiffs but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter was submitted. Written statement was also filed.

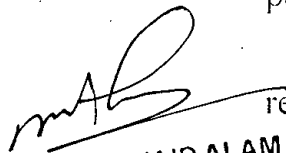
Representative of defendants stated that according to NADRA SOPs there shall be at least 16/17 years' age difference between parents with their children's. Per record, date of birth of plaintiff No.1

recorded as 1970 and correct date of birth of plaintiff No.2 is 1970

while date of birth of plaintiff's son namely Noor Jan recorded as

1988 and correct date of birth of plaintiff's daughter namely Mst:

Baghicha Bibi recorded as 01.01.1998 resulting into unnatural age

gap of about 08 and 06 years. Plaintiffs are not a government servant.

The modification sought by plaintiffs will not affect rights of others.

Representative of defendants stated that date of birth of plaintiffs

may be modified as per NADRA SOPs. There is no need of

recording evidence of the parties. Defendants are directed to rectify

date of birth of plaintiff No.1 & plaintiff No.2 are 1988 respectively.

Suit of plaintiffs is decreed as prayed for. No order as to cost. This

decree shall not affect rights of others interested, if any. This decree

shall not affect service record of plaintiff, if any.
