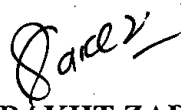

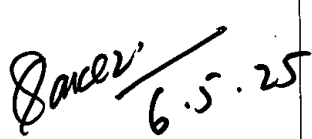

Accused/petitioner: Ihsan Ullah s/o Qasim Khan r/o Caste Mishit, Tapa Haider Khel, Central Orakzai in person along with Mr. Khursheed Alam Advocate present. The accused/petitioner seeks pre-arrest bail in case FIR no. 21, dated 13.04.2025, u/s 302/427/109/34 PPC, of PS Mishti Mela. Accused/petitioner claimed innocence and malafide involvement. The application is supported by an affidavit. At the moment, there is no record before the court.
