ORDER

Sr. PP for the State present. Mr. Abid Ali  
Advocate for accused/petitioner present. Record  
received.

2. The accused/petitioner namely, Inam Gul S/O  
Meena Gul R/O Kamar Khel, Minzany Tehsil Bara  
District Khyber is seeking his post arrest bail in case  
FIR No. 23, Dated 20.05.2025, registered U/S 9 (1) (3)  
(c) KP CNSA, registered at Police Station Kurez Boya.

3. Facts of the case are that, Islam Ali ASHO sent  
Murasila through constable Raheem Ali No.492  
according to which he along with constables Baqir Ali  
no.592, Raheem Ali no.492 were in private motorcar  
were on gasht at Ghodzara road near Krash Plant.  
During Gasht a pedestrian having bag in his right hand  
coming from Anjani side was stopped being suspicion  
and his body search was conducted, but nothing  
incriminating was recovered. On checking the bag  
having black in colour, one packet chars wrapped in  
yellow scotch tape was recovered. On weighing  
through digital scale, it came out to be 1000 grams. 10  
grams was separated from the packet through sharp  
object and sealed in parcel No. 1 for FSL for chemical

examination; while remaining 990 grams chars along with empty bag was sealed into parcel No. 2. Video of the recovered chars was prepared on the mobile phone through Constable Raheem Ali no.492 which was converted into USB and sealed into parcel No. 3. One stamp of "I-A" was put inside the parcel, while 3/3 stamps was affixed on the parcel. The person disclosed his name as Inam Gul S/O Meena Gul R/O Kamar Khel, Yousaf Khel, Tehsil Bara District Khyber, who was found to be involved in the commission of offence. He was arrested at the spot. His card of arrest was prepared. Murasila along with card of arrest and recovery memo were sent to the PS for registration of instant FIR;

4. Arguments heard and available record perused which shows that allegedly the accused/petitioner is charged for having 1000 grams of chars in his possession. The police have not annexed any history sheet regarding involvement of accused/petitioner in such like offences with the record which suggest that the accused is first offender. The allegations levelled against the accused/petitioner are yet to be proved. The accused/petitioner has not confessed his guilt before the court. FSI report is yet to be received. I, therefore, accept the instant bail application. Accused/petitioner be released on bail subject to submission of bail bonds in the sum of Rs. 80,000/- with two sureties each, each

in the like amount to the satisfaction of court. The sureties must be local, reliable and men of means.
