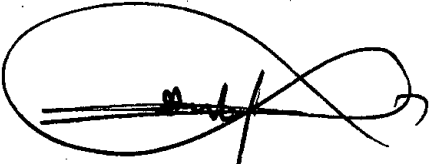

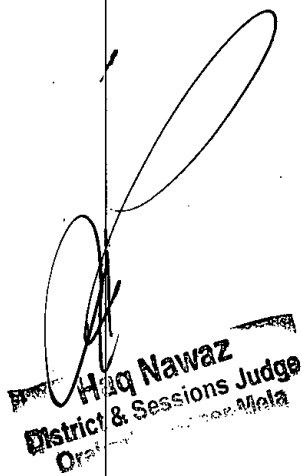

The accused/petitioner seeks Bail Before Arrest in case FIR No. 38, Dated 20.05.2025, u/s 337A(i) 447/34 PPC, Police Station Mishti Mela. Accused claimed innocence and malafide involvement. The application is supported by an affidavit. At the moment, there is no record before the court. Accordingly, accused/petitioner is admitted to ad-interim pre-arrest bail subject to furnishing of surety bonds in the sum of Rs. 80,000/- with two sureties each in the like amount to the satisfaction of this court. Sureties must be local, reliable and men of means. Accused/petitioner is directed to join the investigation and attend the court as and when required on each and every date. Order No.02	29.05.2025	Sr. PP, Abul Qasim for the State present. Accused/petitioner, Mst. Ambara Khela on ad-interim pre-arrest bail along with counsel present. Complainant present in person. He does not was to engage a private counsel. The accused/petitioner seeks pre-arrest bail in case FIR No. 38, Dated 20.05.2025, u/s 337-A(i)/447/34 PPC of Police Station Mishti Mela. As per contents of FIR, the local police, acting on information regarding the incident, reached DHQ Mishti Mela where the complainant/injured Maweez Khan reported the matter to the local police to the effect that he is residing in Hangu and his ancestral property has been leased by him to one, Peer Badshah for cultivation. On 16.04.2025, Peer Badshah was stopped by one of the accused namely, Jameel when he (Peer Badshah) was on his way to cultivate the fields. He informed the complainant regarding the incident. On the eventful day, the complainant went to cultivate his fields where the accused/petitioner along with co-accused armed with pistol and axes were present there and an altercation took place between them whereafter the accused attacked him; as a result of a blow of axe by the accused Jameel, the complainant received injuries on his head. Hence, the present FIR.

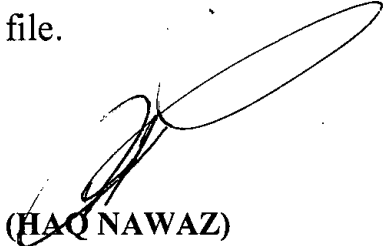
