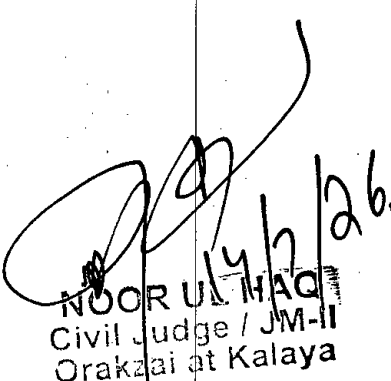

Further stated that respondents, in violation of order dated 07.10.2025, restrained petitioners to harvest the standing crop, while they were directed not to interfere vide above referred order.</p> <p>Contrary to this the respondents stated that they have not violated any order passed by the Court. produced by petitioner to show that any violation of court order has been committed by respondents. Moreover, after institution of instant contempt of court petition, the bailiff was directed to submit his inquiry report after spot inspection. Accordingly, bailiff visited the spot on 17.10.2025 and submitted his detailed report before this Court, wherein he stated that the crop in the suit property has already been harvested. The report further stated that two rooms in dilapidated condition were lying vacant in the suit property. That no construction work is carried out in the suit property. Moreover, it has not been brought on record whether party was in knowledge of the court order or not. The report of bailiff supports the version of respondents and the respondents has denied the allegations. It is also on record that the opposite party has filed similar contempt petition, which shows that the parties are unnecessarily pulling each other on the same property, title of which is yet to be proved by each of them.

In light of above discussion and keeping in view the bailiff report, instant contempt of court petition is hereby dismissed. No order as to costs.
