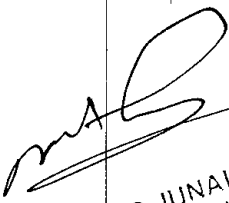

Order -01	07.05.2025	Fresh bail petition submitted. It be registered. None present for the State. Accused/petitioner through brother alongwith counsel present. Record received. Accused/petitioner namely Gul Rahim son of Doormar Jan, resident of Qom Feroz Khel, Saam, District Orakzai, seeks his post arrest bail in case FIR No. 30 dated 29.03.2023 under sections 56 Mineral Act, 2017, Police Station Kalaya, District Orakzai. Arguments of learned counsel for accused/petitioner heard. Perusal of the record reveals that the accused/petitioner is charged for un-authorized mining u/s 56 of the Khyber Pakhtunkhwa, Mineral Sector Governance Act, 2019. The offence with which accused/petitioner^{is} are charged does not fall within the ambit of prohibitory clause of section 497 Cr.PC. In such like cases grant of bail is a rule and refusal an exception. No extra ordinary circumstances exist to justify departure from the said rule. Nothing incriminating has been recovered from possession of accused or on his pointation. No vehicle or loaded minerals have been recovered from the spot. Accused/petitioner has not been arrested at the spot and the source of information regarding involvement of accused/petitioner in the

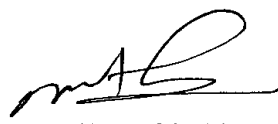

commission of offence has not been disclosed by the complainant. Furthermore, accused/petitioner is senior citizen and also patient of diabetes and high blood pressure. Moreover, accused/petitioner has not confessed his guilt before the court. Investigation has already been completed and accused/petitioner is no more required to the local police for further investigation and no useful purpose would be served by keeping the accused/petitioner behind the bar.

Consequently, application in hand is allowed. Petitioner be released on bail subject to furnishing bail bonds in the sum of Rs. 50,000/- (Fifty thousand) with two sureties each in the like amount to the satisfaction of this court. Copy of this order be placed on police as well as judicial record. Record be returned back to quarter concerned.
