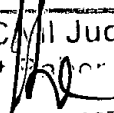

Order No. 02 continued	29.05.2025	Hearing the arguments of learned counsel and perusing the record it appears that petitioner is the driver (last possessor). He is accompanied by son of the owner of the truck who produced original documents of the truck for examination by the court. He also produced relevant receipts issued by the mine authorities for transit of the coal. The truck is no more required to the local police for investigation or any other purpose. There is no rival claimant of the truck at present. Moreover, there is strong apprehension of the damage to the truck if kept in the PS for indefinite period. In view of above, Instant Superdari petition in respect of both the truck and its contents i.e. coal, is accepted subject to furnishing surety bond in sum of Rs. 30,00,000/- (three million) along with two local reliable and resourceful sureties, each in the like amount to the satisfaction of S.H.O of PS Kurez Boya, L/Orakzai. Petitioner shall be bound to produce it before court of law if required by courts or authorities in respect of the case in hand. Record be returned to quarter concerned. A copy of this order shall be placed on Judicial as well as on Police file.
