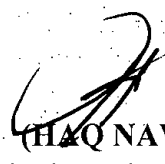
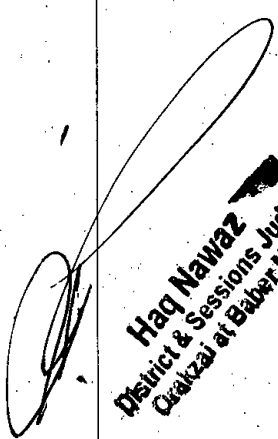

Resultantly, the appeal is accepted. The impugned order dated 28.04.2026 and the ex-parte judgment and decree dated 31.10.2023 passed in Civil Suit No. 39/1 Of 2023 are set aside. The case is remanded back to the trial Court for further proceedings in accordance with law subject to payment of cost of Rs. 40,000/-.
