At the very out set accused mentioned above stated at the bar that they want to confess their guilt in the instant case and in this respect they also submitted an application for plead guilty, which is placed on file. Brief facts of the case are that as per version of the FIR, that SHO/complainant alongwith police officials were present on barricade at metal road <i>Geedare</i>, Orakzai. In the meanwhile, two persons were on motorcycles coming from Feroz Khel side were stopped for the purpose of checking. Accused were deboarded from the motorcycle. One driver of the motorcycle disclosed his name as Mubasher Ahmad. Upon his body search, SHO/complainant recovered and took into possession one plastic envelope in white color containing ice from the side pocket. On weighing through digital scale, it came out 22-grams ice. The other one disclosed his name as

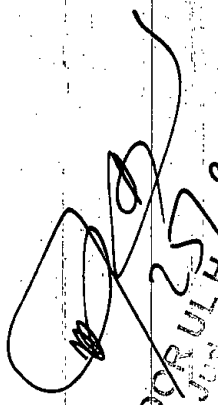

		Irfan Ullah, upon his body search, the local police recovered and took into possession one plastic envelope in white color containing ice. On weighing through digital scale it came out 23-grams ice. One gram each was separated for FSL examination, which was packed and sealed into parcel no. 01 & 03 respectively, while remaining stuff of ice i.e. 21 & 22-grams ice were duly packed and sealed into parcel no. 04. The videography was made by constable Abid Ullah belt no. 2097 through his mobile and saved in the USB, which was packed and sealed into parcel no. 05. One seal each was put inside the parcels while affixed 3/3 seals of monogram with the name of SH on the parcels. The local police also took into possession one motorcycles Honda-125 from the accused Mubasher Ahmad, bearing engine no. T985907 & chassis no. EC 670889 in red color and another motorcycle Honda-125 recovered from accused Irfan Ullah bearing engine no. Z 431135 & chassis no. ED113294. SHIO/complainant prepared recovery memo on the spot in the presence of marginal witnesses. Accused were arrested on the spot and issued their card of arrest.

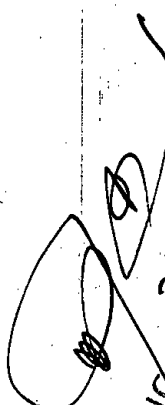

Murasila was drafted on the spot. On the strength of Murasila the instant FIR no. was lodged against the accused facing trial.

Complete challan against the accused was put in court today and after 241-A Cr.P.C proceedings, the accused facing trial filed an application for pleading their guilt and requested for lenient view. After pleading their guilt, show cause notices under section 243 Cr.P.C. were given to the accused as to why they should not be convicted. Resultantly, they prayed for lenient view while placing their self at the mercy of this court.

It is also pertinent to mention here that there is nothing such available on the record which could suggest that accused facing trial were previously involved in such like cases. There is also no criminal history of the accused available on the file.

Keeping in mind the wholehearted confession of guilt by the accused Mubasher Ahmad and Irfan Ullah and being a first offenders, a lenient view is taken and accused facing trial are convicted and sentenced for offence under sections 11-(i) 2 CNSA with simple imprisonment of 06

		vi. That Probation Officer is authorized to involve the probationers in any suitable community service, as provided under Probation and Parole Act. vii. That if they violates the above conditions, the bonds will be recalled and they will be proceeded in accordance with the provision of the Ordinance <i>ibid</i>. viii. That in case of default by the convict, the direction regarding probation shall stand recalled and convict shall undergo imprisonment accordingly. ix. 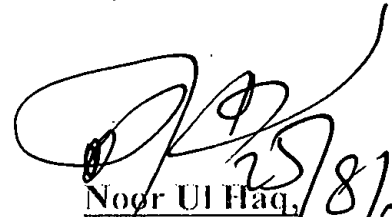
