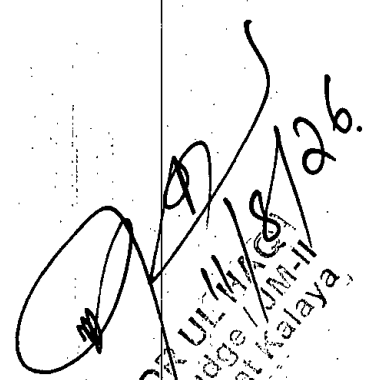

Brief facts of the case are that as per version of the complainant in the FIR bearing no. 114 dated 02.10.2025 under section 11(i) 2 KP CNSA, that on 02.10.2025 at about 1900 hours, SHO/complainant along with police officials were on area patrolling. In the meanwhile, one person in suspicious condition was stopped for the purpose of checking. Upon his body search, the local police recovered and took into possession one white plastic envelope containing ice. On weighing through digital scale it came out 45-grams ice. One gram was separate for FSL examination, which was packed and sealed into parcel no. 01 while remaining stuff of ice i.e. 44-grams was duly packed and sealed into parcel no. 02. 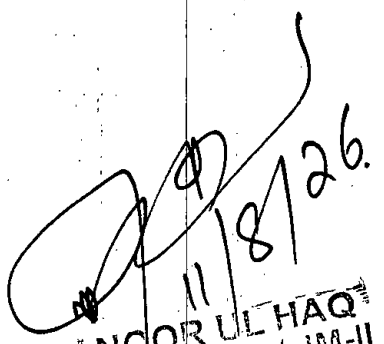

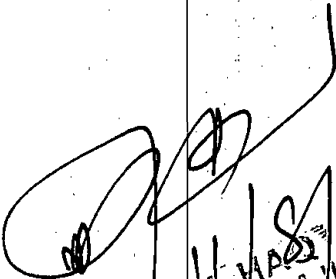

		packed and sealed into parcel no. 03. 3/3 seals of monogram with the name of AM was put inside the parcel while affixed 01 seals was put inside each parcel. Accused disclosed his name as Tehsin Ali son of Jamid Ali. Accused was arrested on the spot and issued his card of arrest. SHO/complainant prepared recovery memo on the spot in the presence of marginal witnesses. Murasila was drafted on the spot. On the strength of Murasila the instant FIR was lodged against the accused facing trial. Complete challan against the accused was put in court today and after 241-A Cr.P.C proceedings, the accused facing trial, filed an application for pleading his guilt and requested for lenient view. After pleading his guilt, show cause notice under section 243 Cr.P.C. was given to the accused as to why he should not be convicted. Resultantly, he prayed for lenient view while placing himself at the mercy of this court. It is also pertinent to mention here that there is nothing such available on the record which could suggest that accused facing trial was previously involved in such like cases. There is also no criminal history of the accused available on the file.

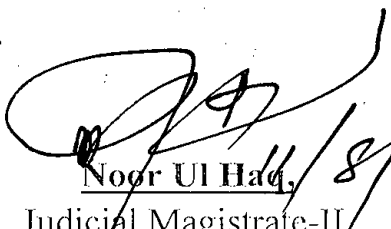

		Keeping in mind the wholehearted confession of guilt by the accused Tehsin Ali and being a first offender, a lenient view is taken and accused facing trial is convicted and sentenced for offence under sections 11-(i) 2 PKCNSA with simple imprisonment of 06 months with fine of Rs. 10,000/-. In default of payment of fine the accused shall undergo simple imprisonment for a period of 01-month. Furthermore, there is nothing on record which could show previous involvement of accused in such like cases, being first offender, thus, the sentence and conviction ibid is suspended and converted into probation and he is placed on probation for the period of 06 months. He shall remain under the supervision of the Probation Officer (male) for the above-mentioned period subject to furnishing bail bonds in the sum of Rs. 50,000/- with two local and reliable sureties, to the satisfaction of probation officer (male) Orakzai with the following conditions. - That he shall not repeat the offence. - That he shall keep and maintain peace and order in the society. - That he must exhibit good behavior during the prescribed period of probation.

That he shall not leave the country without permission of probation officer. vi. That Probation Officer is authorized to involve the probationer in any suitable community service, as provided under Probation and Parole Act. vii. That if he violates the above conditions, the bonds will be recalled and he will be proceeded in accordance with the provision of the Ordinance ibid. viii. That in case of default by the convict, the direction regarding probation shall stand recalled and convict shall undergo imprisonment accordingly. ix. The Probation Officer (male) is directed to submit his report to this court about their character and conditions as aforesaid once in a quarter. Copy of this order be sent to the probation officer for compliance as per law. Case property be dealt with in accordance with law.
