suit for declaration cum-permanent injunction to the effect that, as per
Detailed Marks Certificate (matric) issued by defendant No.4 her true
and correct date of birth is 23.11.2000, however, defendant No.1 to 03
have incorrectly entered the same as 15.09.2008 which is wrong, illegal
and ineffective upon the rights of plaintiff and liable to be rectified. That
defendants were asked time and again to rectify date of birth of plaintiff
but in vain hence, the present suit.

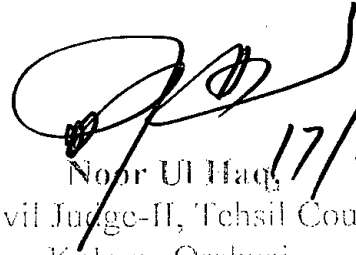

With due process of law and procedure, the defendants were summoned, defendant No.1 to 03 appeared through representative. Authority letter and written statement was filed.

Plaintiff has placed reliance on Detailed Marks Certificate issued by defendant No.04. Per DMC date of birth of plaintiff is recorded as 23.11.2000. Representative of defendant No.1 to 03 stated that date of birth of plaintiff may be modified as per DMC per NADRA SOPs. Copy of DMC of plaintiff is placed on file. Original seen and returned. Copy of the same is placed on file. As date of birth of plaintiff is recorded as 23.11.2000 in DMC (Matric), therefore, there is no need of recording evidence of the parties.
