SUMMARY JUDGEMENT

Plaintiff through counsel present. Representative of defendants absent. Today, the case was fixed for framing of issues however, counsel for plaintiff request for summary disposal. Arguments heard and record perused.

Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that, as per Detailed Marks Certificate (matric) & Service Record his true and correct date of birth is **01.04.1994**, however, defendants have incorrectly entered the same as **01.01.1989** which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

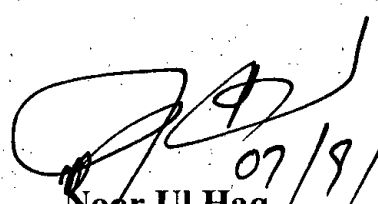

With due process of law and procedure, the defendants were summoned, defendants appeared through representative. Authority letter and written statement was filed.

Plaintiff has placed reliance on Detailed Marks Certificate and service record. Per DMC and service record date of birth of plaintiff is recorded 01.04.1994. Representative of defendants stated that date of birth of plaintiff may be modified as per DMC & Service Record per NADRA SOPs. Copy of DMC and Service Record of plaintiff is placed on file.
