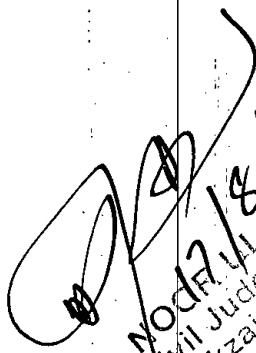

The recovered motorcars have found in suspicious condition. Whereupon, the same inquiry under section 523/550 Cr. PC was initiated, after permission from the court.

During inquiry the recovered vehicles were sent to FSL for chemical examination of chassis/engine numbers vide application no. 1655/PA/DPO Ork dated 24.06.2026. Upon receiving separate FSL reports of each vehicles, the vehicles were found clear with remarks i.e. "No other number has been deciphered in its chassis number". When the chassis numbers were found to be clear, as per FSL reports, separately placed on file, hence, no offence has been committed by the drivers or owners of the vehicles in question. Therefore, by agreeing with report of local police, duly forwarded by prosecution, the instant inquiry is hereby filed without further proceedings.

As a result of filing of the instant inquiry, the local police/IO concerned is directed to hand over the motorcars Prius Model 2014, bearing engine no. 2ZRFXE chassis no. ZVW30-5539333, Toyota Vitz in silver color Model 2003, bearing engine no. 282FE1297MI and chassis no. SOP 13-00042420 and Toyota Alto in red color model 2013, bearing engine no. RO6A and chassis no. HIA365-228423 to their lawful owners, without surety, after proper
