PC upon direction of the Court. Be registered. Owner of the vehicle bearing chassis No. LA300S-1304546 and Engine No. KFVE5L, namely Subhan Ullah S/o Raaz Muhammad having CNIC No.17301-1734290-9 and its last possessor namely Javed Khan S/o Awal Khan having CNIC No.17301-4434118-5 are present. The last possessor has got no objection if the vehicle is handed over to its owner named above.</p> <p>Record reveals that as per Naqal Mad No. 18 dated 17.06.2026, SHO concerned was on area patrolling at Headquarter Chowk, where one motorcar was seen coming from Feroz Khel side. It was stopped for the purpose of checking. The driver of the motorcar Diahatsu Mira in black color bearing engine no. KFVE5L and chassis no. LA300S-1304546, was deboarded who disclosed his name as Javid Khan son of Awal Khan. No incriminating materials have been extracted out of him or the car, however, the accused mentioned above could not produce valid documents regarding the motorcar, he was driving. The recovered motorcar was found in suspicious condition. Whereupon, the same inquiry under section 523/550 Cr. 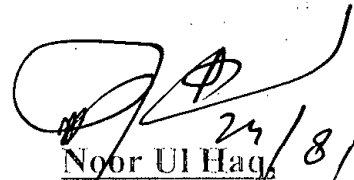
