PC were recorded on 30.07.2026, placed on file.</p> <p>Vide this order the court intends to dispose of instant inquiry under section 174 Cr. PC.</p> <p>During the course of the inquiry, the statements of the legal heirs of the deceased were recorded under Section 164 Cr.P.C, which are duly thumb impressed by them. They consistently stated that the deceased Adnan Ali committed suicide by firing upon himself and that no other person was involved in the occurrence. They further deposed that they have no suspicion or allegations against any person and do not seek any legal action in connection with the death of the deceased Adnan Ali. Furthermore, no material has come on record, indicating the involvement of other persons or disclosing the commission of any cognizable offence warranting a criminal case or further proceedings.</p> <p>The record further shows that the deceased has died due to suicide and no evidence of criminal action has surfaced</p> |

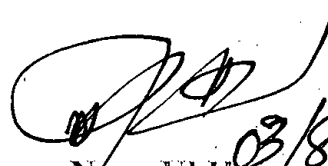
