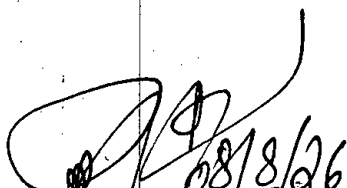

Arguments of both the counsels for the parties heard. Accused/petitioner namely Osama son Mastan, resident of Qom Uthman Khel, District Orakzai has applied for his post arrest bail in connection with case FIR No. 111, dated 30.07.2026 under section 382/506/34 PPC, registered in police station Kalaya. However, at the very outset complainant namely Wajid Khan appeared before the court and recorded his statement, wherein he stated that he has patched up the matter with the present accused/petitioner with the intervention of elders of the locality through a compromise deed and he has pardoned the present accused/petitioner in the name of Almighty Allah and he has got no objection if the accused is released on bail or subsequently acquitted in trial. Copy of CNIC of brother of complainant/identifier is Ex. PA while Compromise deed is Ex. PB. In the light of the statement of complainant, the present accused is entitled to the concession of bail at this stage,

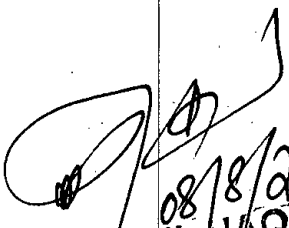

hence, application in hand is **accepted** and he be released on bail, subject to furnishing of bail bonds to the tune of Rs. 100,000/- by the accused with two local and reliable sureties, each in the like amount to the satisfaction of this court.

Counsel submitted an application for return of one motorcycle Honda-125 bearing engine no. Y334488 and chassis no. EG-334476 was taken into possession by the local police in the instant case.

Upon perusal of the record reveals that the motorcycle in question is the ownership of the brother of the complainant. In this respect he also produced the registration copy of the motorcycle in question alongwith invoice, which shows the brother of the complainant Khalid is the last possessor of the same.

Resultantly, the application is accepted and local police is directed that the vehicle in question be handed over to one Khalid, subject to furnishing personal surety bond to the tune of Rs. 100,000/- to the satisfaction of this Court. Whereafter, attested copy of this order along with personal surety bond, be produced before SHO concerned, for release of the subject vehicle. Petitioner shall be bound not to sale the vehicle in question and shall produce the same

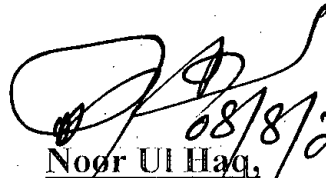
