Case was fixed for attendance of accused. Accused appeared before the Court and stated at the bar that he wants to confess his guilt in the instant case and in this respect, he also submitted an application for plead guilty, which is placed on file.

Brief facts of the case are that as per version of FIR no. 05 dated 08.01.2026 under section 11(i) 3 KPCNSA, That on 08.01.2026 at about 1340 hours at Kalaya Bazar, SHO/complainant alongwith police officials were on area patrolling. In the meanwhile, one person in suspicious condition was stopped for the purpose of checking. Upon his body search, SHO/complainant recovered and took into possession one plastic envelope in white color containing ice from the badda shalwar. On weighing through digital scale, it came out 55-grams ice. One gram was separated for FSL examination, which was packed and sealed into parcel no. 01, while remaining stuff of ice i.e. 54-grams was duly packed and sealed into parcel no. 02. Khan through his mobile and saved in the USB, which was packed and sealed into parcel no. 03. One seal was put inside each parcel while affixed 3/3 seals of monogram with the name of MJ on the parcels. SHO/complainant prepared recovery memo on the spot in the presence of marginal witnesses. Accused was arrested on the spot and issued his card of arrest. Accused disclosed his name as Muhammad Qais son of Israf Ali, resident of Paas Kalaya, District Hangu. Murasila was drafted on the spot. Murasila was sent to the PS through constable Muhammad Khan for registration of instant case. On the strengthen of Murasila FIR was lodged against the accused facing trial.

Complete challan against the accused was put in court today and after 241-A Cr.P.C proceedings, the accused facing trial filed an application for pleading his guilt and requested for lenient view. After pleading his guilt, show cause notice under section 243 Cr.P.C. was given to the accused as to why they should not be convicted. Resultantly, he prayed for lenient view while placing himself at the mercy of this court.

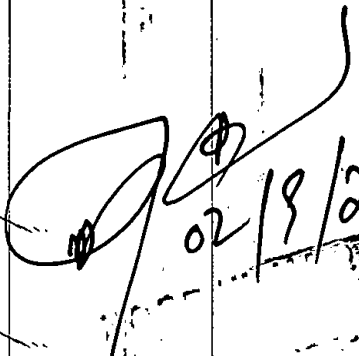

It is also pertinent to mention here that there is nothing such available on the record which could suggest that accused facing trial was previously involved in such like cases. There is also no criminal history of the accused available on the file.

Keeping in mind the wholehearted confession of guilt by the accused Muhammad Qais and being a first offender, a lenient view is taken and accused facing trial is convicted and sentenced for offence under sections 11-(i) 3 CNSA with simple imprisonment of 06 months with fine of Rs. 10,000/- each. In default of payment of fine the accused shall undergo simple imprisonment for a period of 01-month each. Furthermore, there is nothing on record which could show previous involvement of accused in such like cases, being first offender, thus, the sentence and conviction ibid is suspended and converted into probation and he is placed on probation for the period of 06 months. He shall remain under the supervision of the Probation Officer (male) for the above-mentioned period subject to furnishing bail bonds in the sum of Rs. 50,000/- with two local and reliable sureties, to the

satisfaction of probation officer (male) Orakzai with the
following conditions.

- i. That he shall not repeat the offence.
- ii. That he shall keep and maintain peace and order in the society.
- iii. That he must exhibit good behavior during the prescribed period of probation.
- iv. That he shall appear before the probation officer once in a month, which date is left to the discretion of the probation officer to be fixed.
- v. That he shall not leave the country without permission of probation officer.
- vi. That Probation Officer is authorized to involve the probationers in any suitable community service, as provided under Probation and Parole Act.
- vii. That if he violates the above conditions, the bonds will be recalled and they will be proceeded in accordance with the provision of the Ordinance ibid.
- viii. That in case of default by the convict, the direction regarding probation shall stand recalled and convict shall undergo imprisonment accordingly.
- ix. The Probation Officer (male) is directed to submit their report to this court about their character and conditions as aforesaid once in a quarter. Copy of this order be sent to the probation officer for compliance as per law.

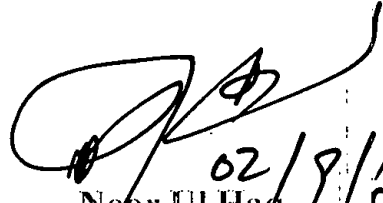
