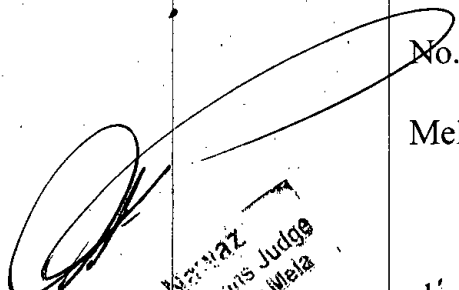

Order No.01	17.08.2026	Complete Challan along with supplementary challans received from the Court of Judicial Magistrate-II, Kalaya, Orakzai. It be registered. Accused Muhammad Islam, Mehmood Nawaz and Zahir Ullah are on bail. They be summoned for 31.08.2026.  (HAQ NAWAZ) Sessions Judge, Orakzai
Order No.02	31.08.2026	Sr. PP, Abul Qasim for the State present. Accused Muhammad Islam, Mehmood Nawaz and Zahir Ullah present. Complainant Haleef Shah also present. The case was registered against the accused Zahir Ullah S/O Islam Khan, Mehmood Nawaz s/o Islam Khan and Islam Khan s/o Behram Shah, Caste Mishti, Tapa Haider Khel, PO Mishti Mela, Tehsil Central, District Orakzai FIR No. 13, Dated 06.03.2026, registered at police station Mishti Mela u/s 4 Ghag Act. At the very outset, the accused stated that they were charged in case FIR No. 13, Dated 06.03.2026 at police station Mishti Mela u/s 4 Ghag Act read with section 34 PPC. They have patched up the matter with the complainant, Haleef Shah and have assured him that they have got no objection on the marriage of his daughter, Mst. Nihayat Bibi who may marry with anyone according to her will in accordance with Shariah. The finally requested that the case may kindly be disposed off on the basis of compromise.

		The complainant also submitted that he charged the accused Muhammad Islam, Zahir Ullah and Abdul Mehmood in case FIR No. 13, Dated 06.03.2026 at police station Mishti Mela u/s 4 Ghag Act read with section 34 PPC for raising Ghag against his daughter Mst. Nihayat Bibi. He has patched up the matter with the accused and has forgiven them in the name of Allah, after their assurance that they will get no objection on the marriage of his daughter, Mst. Nihayat Bibi who may marry with anyone according to her will in accordance with Shariah. He finally requested that the case may kindly be disposed off on the basis of compromise and the accused may be acquitted from the charges levelled against them. In view of the above, the compromise is accepted and the accused Zahir Ullah S/O Islam Khan, Mehmood Nawaz s/o Islam Khan and Islam Khan s/o Behram Shah, Caste Mishti, Tapa Haider Khel, PO Mishti Mela, Tehsil Central, District Orakzai are acquitted of the charges levelled against them on the basis of compromise. The accused are on bail. Their bail bonds cancelled and the sureties are discharged of the liabilities of bail bonds.
