The accused Qismat Khan s/o Nooran Shah, Caste Zakha Khel was charged in case FIR No. 16, Dated 14.03.2026 registered at Police Station Mishti Mela, on the basis of recovery of 800 grams chars from his possession which falls U/S 9 (1) 3 (b) CNSA. Thus, in view of his clean breast plead guilty, the accused is convicted u/s 9 (1) 3 (b) CNSA to undergo rigorous

		imprisonment for a period of eight (08) months and pay a fine of Rs. 80,000/-. In default of payment of fine, the accused shall suffer further simple imprisonment for one (01) month. According to the available record, the convict is first offender. Besides the convict is of old age; therefore, while taking lenient view, the sentence awarded to the convict is suspended under Section 4-D of the Khyber Pakhtunkhwa Probation and Parole Act, 2021 and he is placed under the supervision of the Probation Officer, Orakzai, for a period of one year subject to furnishing surety bonds to the tune of Rs. 100,000/- with two sureties each in the like amount to the satisfaction of the Probation Officer, Orakzai. The sentence of fine shall stands merged with the period of probation. Copy of the Order be sent to the Probation Officer, Orakzai for doing the needful in accordance with probation law/rules. The terms and conditions of probation Order, its effects, bond and the consequences of breaching the conditions during the probation period were explained to the convict in Pashto language as required under Section 6 (4) of the Khyber Pakhtunkhwa Probation and Parole Act, 2021. Case property be destroyed after the period of appeal/revision.
