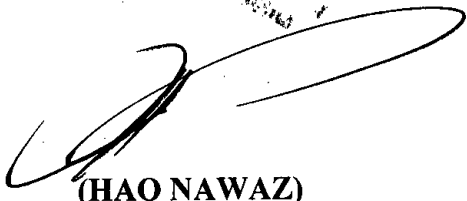

Order No.01	24.08.2026	Complete challan received from the Court of Judicial Magistrate-II Kalaya, Orakzai. It be registered. Accused Rasheed Khan, Anwar Ullah and Shahid Ullah are on bail. They be summoned for 08.09.2026.  (HAQ NAWAZ) Sessions Judge, Orakzai at Baber Mela
Order No. 02	08.09.2026	Sr. PP, Abul Qasim for the State present. Accused Muhammad Rasheed present while accused Anwar Ullah and Shahid Ullah absent. Complainant Saif Uddin present. This case was registered against the accused Rasheed Khan s/o Nadar Khan, Anwar Ullah s/o Rasheed Khan and Shahid Ullah s/o Abdul Rehman, Caste Feroz Khel, vide FIR No. 91, Dated 03.07.2026 at Police Station Kalaya u/s 324/34 PPC. Joint statement of the complainant and the accused Muhammad Rasheed recorded. They stated that the instant case FIR No. 91, Dated 03.07.2026 was registered against the accused Rasheed Khan and two others. They have patched up the matter outside the Court through local jirga. According to which, the landed property Ali Khel fields, jointly owned with Mowali and the land purchased from Muhammad Ayaz, situated towards south of the house of Ibrahim with width of 15 feet and length up to thoroughfare, will be the ownership of complainant party. The thoroughfare in front of the house of Ibrahim pertains to the accused party; however, it will be used by both the parties. In case of violation, the violator shall pay the fine of Rs. 1,000,000/- to Jirga out which 300,000/- will be deposited to government. Another field in the name of Muhammad Ayyaz is handed over to the

		complainant party along with its crops. The complainant has also received an amount of Rs. 200,000/- for the injury sustained by him. In case of violation of the agreement, an amount of 4,000,000/- will be deposited with Jirga members by the violator out of which 2,000,000/- will be deposited with the government. In case of construction in the above mentioned 15 feet width area up to thoroughfare in length, the water drainage and window etc. shall not be opened towards other party. The written compromise is submitted which is Ex. PA. The copies of our CNICs are Ex. PB and Ex. PC. They finally requested that the compromise may kindly be accepted and the accused be acquitted on the basis of compromise. Since, the offence is compoundable in nature; therefore, the compromise is accepted and the accused Rasheed Khan s/o Nadar Khan, Anwar Ullah s/o Rasheed Khan and Shahid Ullah s/o Abdul Rehman, Caste Feroz Khel are acquitted of the charges levelled against them on the basis of compromise. The accused are on bail. Their bail bonds are cancelled and the sureties stand discharged of the liabilities of bail bonds.
