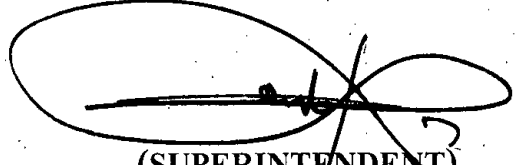
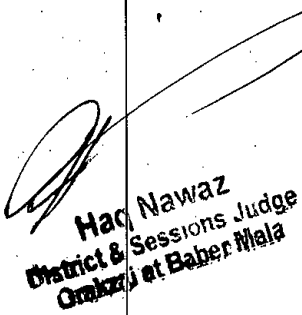

		on 07.02.2026 and found the injured Muhammad Shahid in the emergency room. He reported the matter to the local police at 1945 hours to the effect that he was taking cattle to his house from nearby fields on the eventful day when the accused/petitioner and co-accused made firing at him at 1810 hours with the intention to kill him and that he sustained injuries on his left thigh from the firing of accused/petitioner while the co-accused caused him injuries on his shoulder. They also made firing upon house of the complainant. Hence, the present FIR. It is evident from perusal of the FIR that the accused/petitioner was charged for causing injuries to the complainant who has already recorded his statement raising no objection on the acceptance of bail application of the accused/petitioner as he has effected compromise with him. Moreover, the offence is compoundable in nature. In view of the above, the application is accepted and the accused/petitioner is admitted to bail subject to submission of bail bonds to the tune of Rs. 100,000/- with two sureties each in the like amount to the satisfaction of this Court. The sureties must be local, reliable and men of means. Copy of this Order be placed on police/judicial file.
