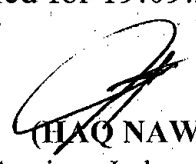
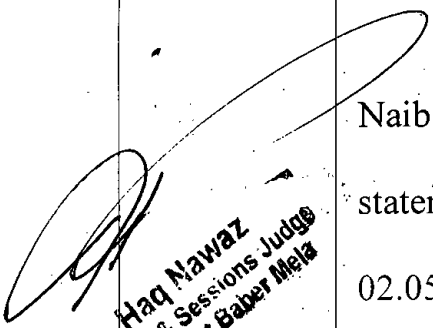


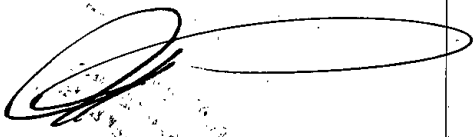

This case was registered against the accused Ahmad Faraz, Zain Ullah, Zahid Ullah sons of Jan Akbar, Hameed Ullah, Shah Nawaz, Shamid Ullah, Arshad Ullah sons of Said Khalil, Imitaz s/o Wazif Khan, Aneef Khan s/o Ilyas Khan and Rizwan Ullah s/o Khial Akbar vide FIR No. 26, Dated 02.05.2026 at Police Station Mishti Mela u/s 324/337-A(i)/148/149 PPC. At the very outset, the injured Gulistan and Abdul Naib appeared before the Court and recorded their statement. They stated that the case FIR No. 26, Dated 02.05.2026 was registered at Police Station Mishti Mela u/s 324/337-A(i)/148/149 PPC against the accused Ahamad Faraz and 09 others for causing injuries to them along with minor Riaz. They have patched up the matter with all the accused outside the court and have effected a genuine compromise with them. They requested that the

		accused be acquitted on the basis of compromise. The injured Riaz being minor is represented by Gulistan as his father. Since, the offence is compoundable in nature; therefore, the compromise is accepted and the accused Ahmad Faraz, Zain Ullah, Zahid Ullah sons of Jan Akbar, Hameed Ullah, Shah Nawaz, Shamid Ullah, Arshad Ullah sons of Said Khalil, Imitaz s/o Wazif Khan, Aneef Khan s/o Ilyas Khan and Rizwan Ullah s/o Khial Akbar are acquitted of the charges levelled against them u/s 324/337-A(i)/148/149, PPC on the basis of compromise. The accused are on bail. Their bail bonds stand cancelled and the sureties are discharged of the liabilities of bail bonds. Case property be dealt with in accordance with law.
