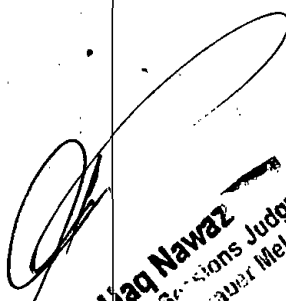

Order No.01	18.08.2026	Juvenile Challan received from the Court of Judicial Magistrate-II, Kalaya, Orakzai. It be registered. Accused are on bail. They be summoned for 19.09.2026.  (HAQ NAWAZ) Sessions Judge, Orakzai at Baber Mela
Order No. 02	19.09.2026	DPP for the state present. Accused present on bail. The injured Zain Ullah, Ahmad Faraz and Hamid Ullah present. Jan Akbar, the father of injured Zain Ullah appeared through video edlink. This case was registered against the accused Muhammad Riaz s/o Gulistan, Shaukat Ullah s/o Maseed Gul and Zahir Ullah s/o Farid Khan vide Daily Diary No. 18 in case FIR No. 26, Dated 02.05.2026 at Police Station Mishti Mela u/s 337-F(i)/148/149 PPC. At the very outset, the injured Ahmad Faraz and Hameed Ullah appeared before the Court whereas the injured Zain Ullah, being minor, is represented by his father through video link from Tabligh through cell No. 0303-9500043 and recorded their statement in the main case. They stated that the DD No. 18, Dated 02.05.2026 was registered at Police Station Mishti Mela u/s 337 F(i)/148/149 PPC in case FIR No. 26 of the same date against the accused Gulistan and 09 others for causing

		injuries to them and minor Zain Ullah. They have patched up the matter with all the accused outside the court and have effected a genuine compromise with them. It is requested that the accused be acquitted on the basis of compromise. Since, the offence is compoundable in nature; therefore, the compromise is accepted and the accused Muhammad Riaz s/o Gulistan, Shaukat Ullah s/o Maseed Gul and Zahir Ullah s/o Farid Khan are acquitted of the charges levelled against them u/s 337-F(i)/148/149 PPC, on the basis of compromise. The accused are on bail. Their bail bonds stand cancelled and the sureties are discharged of the liabilities of bail bonds. Case property be dealt with in accordance with law.
