Order-08	31.08.2026	Learned APP for the State present. Accused Amjad Ali absent. Complainant along with learned counsel present. Record reveals that on previous date, surety of above named accused, namely Syed Qaim Ali Shah had appeared and requested the court to give him time for production of accused. Today, the said surety appeared and stated at the bar that he is unable to produce the accused as he avoids appearance before the court and has gone into hiding. As per record, the accused named above is charged in FIR No.50, dated 12.12.2023 under section 379/34 PPC, Police Station Mishti Mela, Orakzai. He had earlier absconded whereupon the local police had submitted challan against him U/s 512 CrPC where statements of PWs were recorded. He, later on, surrendered before the law and the accused secured bail from the court. Trial was accordingly initiated. Now, the accused has again absconded and is not appearing before the Court. His sureties were noticed, one of the sureties appeared, who was given sufficient time for production of accused, but he also failed to produce him and also admitted this fact. Hence, proceedings against the accused named above U/s 512 CrPC are initiated. Learned APP was asked about production of evidence, who stated that he relies on already recorded evidence of PWs. Keeping in view the available record and statement of PWs, this court is satisfied that a prima facie case exists against the absconding accused namely Amjad Ali and other co-

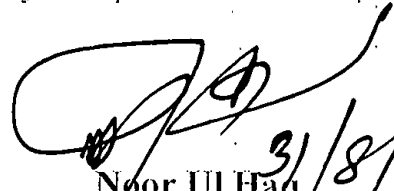

Proceedings U/s 514 CrPC be also initiated against the sureties of the accused. Moharrir is directed to prepare separate file under the said section. Police file be returned, while file of this court be consigned to record room after necessary completion and compilation.
