Learned APP for the state present. Owner of the vehicles appeared and submitted application for return of his vehicles. Record was requisitioned.

Record shows that an inquiry under section 156(3) Cr.PC was allowed by this Court, regarding vehicles bearing Chassis No.S500P-0092384 Engine No. KFVI4658 and another Chassis No.DA16T-247102 Engine No.RO64, both registered in the name of Muhammad Murad, as per NDP Registration by Excise Department of District Khyber.

Owner Muhammad Murad, bearing CNIC No.14101-9787058-7, has produced the excise documents as well as purchase receipts in respect of the vehicles mentioned above. Original documents seen and returned, while photocopies placed on record. Last possessor of one of the vehicles also present, who is Shabir Khan S/o Shahin Badshah, bearing CNIC No.14101-3153269-3. He has got no objection, if the vehicle is returned to its owner.

Record/final report reveals that as per Naqal Mad No.14 dated 23.08.2026, the local police of PS Mishli Mela, while patrolling, have seized the above vehicles upon suspicion. No incriminating materials have been extracted out of the drivers or the vehicles, however, the accused mentioned above could not produce valid documents regarding the vehicles. Whereupon, the inquiry under section 523/550 Cr.PC was initiated, after permission from the court.
