SUIT FOR DECLARATION & PERMANENT INJUNCTION.

Judgment:

Through this judgement this court is going to dispose of the instant suit filed by plaintiff against the defendants for declaration cum-permanent injunction.

Brief facts of the case are that plaintiff brought the instant suit for declaration cum-permanent injunction to effect that correct father name of plaintiff is ***Gul Saeed*** however; defendants have incorrectly entered the same is ***Gul Said*** which are wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That defendants were asked time and again to do the needful but in vain, hence the present suit.

After institution of the suit, defendants were summoned. Defendants No.1 to 03 marked their attendance through representative and contested the suit by filing written statement. In the written statement representative of defendants have raised several legal and factual objections.

From divergent pleadings of the parties, the followings issues were framed for adjudication of real controversy between the parties.

ISSUES

1. Whether plaintiff has got cause of action? OPP
2. Whether correct father name of plaintiff is **Gul Saeed** however; defendants have incorrectly entered father name of plaintiff as **Gul Said**? OPP
3. Whether plaintiff is entitled to the decree as prayed for? OPP
4. Relief?

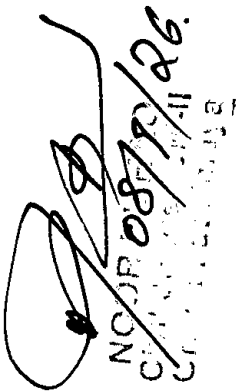
Upon submission of list of witnesses, both the parties on being provided with an opportunity to adduce their desired evidence, the parties produced their evidence.

After the completion of evidence, arguments of the counsel for plaintiff and contesting defendants were heard and record of the case file was gone through with their valuable assistance.

My issue wise findings are as under: -

ISSUE NO.02.

During course of recording evidence, plaintiff herself appeared and deposed as PW-01. She stated that her correct father name is Gul Saeed however, defendants have incorrectly entered the same as Gul

Said. She further stated that she has three brother namely Wazir Janan (late), Janab (late) and Nazrat Janan (alive). Copy of her CNIC is Ex.PW-1/1, copy of her father CNIC is Ex.PW-1/2. Her husband name is Malak Mimla Jan, who is also died. Death certificate of her father is Ex.PW-1/3 and death certificate of her husband is Ex.PW-1/4.

During cross examination she stated that she does not know when she obtained her first CNIC. She further stated that today, she produced her brother before the court for recording his statement. Father name Gul Saeed is correctly mentioned in his brother's CNIC.

Nazrat Janan brother of plaintiff appeared and record his statement as PW-02. He stated that his correct father name is Gul Saeed however, defendants have incorrectly entered Gul Said. He further stated that he has two other brother namely Janab and Wazir Janan and both are died. Copy of his CNIC is Ex.PW-2/1.

During cross examination he stated that he did not know when his sister obtained her first CNIC. Father name of Gul Saeed is Said Badshah.

Thereafter, evidence of plaintiff was closed.

Iftekhhar Ahmad (Representative of NADRA) appeared and deposed as DW-1. He produce family tree of plaintiff is Ex.DW-1/1 & Ex.DW-1/2. As per NADRA record father name of plaintiff is Gul Said. As per NADRA SOPs for changing name of parent, brother or sister were necessary to perform biometric. He lastly requested that the plaintiff be directed to approach the NADRA office for the

requisite verification/correction in accordance with the NADRA SOPs.

During cross examination he stated that it is correct that Nazrat Janan is present before the court today, who is fit and mentally balanced. It is also correct that Gul Saeed is correctly mentioned in CNIC of Nazrat Janan in the column of parentage.

Claim of plaintiff is that her true and correct father name is **Gul Saeed**, but defendants have incorrectly recorded her father name as **Gul Said** in their record, which is wrong and liable to be rectified. Oral evidence produced by plaintiff is also supportive to the averments of plaintiff. Defendants failed to establish that the exhibited record in favor of plaintiff is managed or manipulated one. Moreover, brother of plaintiff namely Nazrat Janan appeared before the court and recorded his statement as PW-02 which also support claim and contention of plaintiff. Plaintiff produced cogent, convincing as well as oral evidence in support of his claim and contention.

Keeping in view the above discussion and documentary as well as oral evidence available on file, it is held that correct father name of plaintiff is **Gul Saeed**. Issue decided accordingly.

ISSUES NO.1 & 3.

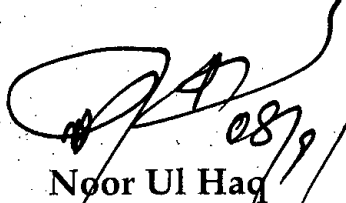
In the light of foregoing discussion, plaintiff has proved her stance through cogent, convincing and oral evidence; therefore, she has got cause of action and is entitled to the decree, as prayed for. Both these issues are decided in positive in favor of plaintiff.

RELIEF.

Crux of my issue wise discussion is that suit of the plaintiff is hereby decreed in her favor against the defendants as prayed for. No order as to costs. This decree shall not affect the rights of any other person interested, if any or service record of plaintiff, if any.

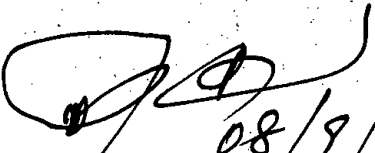
